STUDENT WAIVER OF LIABILITY AND ASSUMPTION OF RISK

In consideration of Elevate Aviation (“Elevate”) permitting the undersigned to use the facilities and property of the Elevate Aviation Learning Centre (EALC) and permitting the undersigned to participate in activities sanctioned by Elevate in connection with EALC at locations other than EALC (collectively, the “Activities”), I _____

HEREBY AGREE as follows: *(print student’s full name)*

1. 2. ASSUMPTION OF RISK I assume and accept: (a) all risks, dangers, and hazards of any cause whatsoever resulting from my participation in the Activities; and (b) full responsibility for my participation in the Activities, my behavior, and my use of the facilities and property of and the equipment and services provided to me by the Releasees.

3. WAIVER AND RELEASE I irrevocably waive, release and discharge the Releasees with respect to any and all actions, suits, liability, claims, and demands of whatsoever kind or nature either in law or equity, including without limitation, for personal or emotional injury, illness, disease, disability, death, and loss or damage to a person or property, both foreseeable and unforeseeable, which arise or may hereafter arise, directly or indirectly, from my participation in the Activities or use of the facilities and property of and the equipment and services provided to me by the Releasees.



4. MEDICAL TREATMENT AND RELEASE OF PERSONAL INFORMATION | in the event of a medical emergency

in which I lack the capacity to consent to treatment as may be determined by the Releasee, I hereby consent to the release of my personal information by the Releasees for the purpose of securing appropriate medical attention and treatment.

5. PHOTO/VIDEO RELEASE I hereby give permission for Elevate Aviation and their assignees, licensees, legal representatives, and transferees to use/publish my photograph/video/image in its various publications, promotional materials, and other media. I understand that Elevate Aviation has exclusive rights to these images. I further waive any and all rights to review or approve any uses of the images, any written copy, or the finished product.
